**Kingfisher Lottery Club Rules**

Friends of Paxton Pits Nature Reserve ( <b>FPPNR</b> )	Membership & Trading Committee ( <b>Committee</b> )
Kingfisher Lottery Club ( <b>Club</b> )	Board of Trustees ( <b>BoT</b> )

1 Objects of the club

a) To raise funds for the Friends of Paxton Pits Nature Reserve

b) To provide prizes for the members of the lottery club

- 2 The Club Promoter (who may be a member of the club) appointed by the BoT will administer the club
- 3 Membership of the club will be open to anyone over the age of 16
- 4 Membership of the club will not be limited to members of FPPNR
- 5 Members are entitled to purchase as many shares in the lottery as they wish
- 6 All shares are non-transferable and should a member no longer wish to participate in the lottery his/her share(s) will be returned to the club for re-issue to other members
- 7 It is the responsibility of members to keep the Club Promoter notified of any change of address or cancellation of membership of the club
- 8 Members will, once their standing order payment has been received, be allocated a unique share number(s)
- 9 Each share will cost £12.00 each year paid by standing order to the Club
- 10 One entry date by standing order - June - for participation in the subsequent draws and thereafter until the member cancels their standing order which in the absence of a notification of withdrawal from the club will be regarded as sufficient evidence of cancellation of membership of the club
- 11 There are four prize draws each year – September, December, March & June (assuming 100 shares 1st prize £100, 2nd prize £50 & 3rd prize £25. If membership is lower than 100 shares 58% of the total fund will be allocated as prizes as follows:- 1st 25%, 2nd prize 15% & 3rd prize 10%
- 12 All draws will be conducted by the FPPNR Treasurer (or in his/her absence by a committee member) in the presence of at least one other committee member
- 13 Members with winning numbers will be notified after each draw at their last known address by the club promoter. A cheque for the amount of the prize will be included with notification.
- 14 Names of winners and prizes won will be displayed in the Visitor Centre and published in the FPPNR Kingfisher Newsletter
- 15 The Club Promoter will determine all disputes at his/her absolute discretion
- 16 The committee may amend or vary the rules of the club at any time
- 17 The lottery is intended to be a Simple Lottery authorised by Huntingdon District Council under the provisions of the Gambling Act 2005 section14 (3)
